## TRAFFIC SPEED ORDINANCE

# TOWN OF SHAFTSBURY

Pursuant to the provisions of Title 23, Vermont Statutes Annotated, Section 1007 and 1008, and Title 24, Vermont Statutes Annotated Sections 1971 and 2291(1)(4) and (5), and such other general enactments as may be material hereto, it is hereby ordained by the Board of Selectmen of the Town of Shaftsbury that the following Traffic Ordinance is adopted for the Town of Shaftsbury, Vermont.

The definitions of Title 23, Vermont Statutes Annotated, Section 4 are incorporated by reference.

The ordinance establishes special traffic regulations on public highways within the Town of Shaftsbury, Vermont.

Section 1: The maximum speed limit permitted for vehicular traffic on the following enumerated Town Highways shall be twenty-five miles per hour:

- TH 1 OLD DEPOT ROAD FROM ARLINGTON TOWN LINE SOUTH TO INTERSECTION OF VERMONT RAIL TRACKS

- TH 8 FROM CIDER MILL ROAD INTERSECTION TO TERMINUS AT OLD DEPOT ROAD
- TH 9 BEGINNING .54 MILES FROM INTERSECTION WITH GRANGER HOLLOW TO IT'S TERMINUS.
- TH 7 MYERS ROAD 1.22 MILES FROM VT RTE 7A TO INTERSECTION OF EHRICH ROAD
- TH 16 JACK CROSS ROAD
- TH 19 CIRCLE DRIVE

#### Section 2

On all Town Highways not specifically enumerated in sections 1 above, the maximum permitted speed limit for vehicular for vehicular traffic shall be thirty-five (35) miles per hour.

### Section 3

All Town Highways shall be appropriately posted to indicate the maximum permissible speed limit for vehicular traffic as set forth in sections 1 and 2 above.

### Section 4

If any provisions of this ordinance are held invalid or void, such provisions shall be deemed to be separate and entirely severable from the other provisions of this ordinance and all other remaining provisions shall remain in full force and effect.

## Section 5

Any prior ordinance or ordinances of the Town of Shaftsbury which are inconsistent with the provisions of this Ordinance are hereby expressly repealed.

### Section 6

A. Section 1. Separate Offenses: Each violation of a provision of this ordinance shall be deemed a separate offense.

- B. Penalties: The provisions of this ordinance shall be cumulative to the fullest extent permitted by law with respect to all other statutes or ordinances now or hereafter adopted regardless of their order of passage or enactment.
- C. Severability: The provisions of this ordinance are declared to be severable and if any provisions hereof be adjudged invalid such judgment shall not affect the validity of any other provisions.
- D. Designation: This ordinance may be referred to as the Traffic Speed Ordinance and in a prosecution hereunder a copy of such ordinance, certified by the Town Clerk shall be prima facie evidence thereof. An allegation that the act constituting the offense charged is contrary to a specified provision of this ordinance shall be a sufficient reference hereto.
- E. Repeal of Prior Ordinances: Any other Speed Zone ordinance heretofore adopted by the Town of is hereby repealed.
- F. Publication and Posting: This ordinance shall be published in the on , 2023 and shall be filled with the Town Clerk on , 2023. Adopted by the Board of Selectmen, Town of at its meeting held on the day of , 2023.
