- 4. Review of Minutes July 16, 2014. Motion to approve with corrections Mr. Biddy, Seconded Mr. Day. Motion carried 3-0.
- 5. Application 14-9490: Mr. Joly 902 VT Rte 7A, Parcel #17-22-30, application for variance on setback for deck. Mr. Day joins Board. Mr. Joly testified that he needed a variance to replace deck as it was constructed prior to house fire. Mr. Joly requests variance for relief of setback requirements from 15' setback to 7' setback. Mr. Joly indicated that the deck would be the same width but a longer length. Questions were asked regarding length and whether the requested size was appropriate.
